WHEREAS the vacancy had to be filled within 30 days in accordance with section 199 of the Act Respecting School Elections;

WHEREAS the Council of Commissioners approved resolution #CC-171120-CA-0041, initiating call for nominations for candidates to submit their interest by November 30, 2017;

WHEREAS a public notice was published on the school board's Facebook page on November 20, 2017 and in local newspapers on November 22 and 23, 2017, seeking external nominations for the vacant position of commissioner in electoral division #2;

WHEREAS two eligible applications were received for the position of Commissioner for electoral division #2 (Lachute);

WHEREAS the Chairperson of the Sir Wilfrid Laurier School Board wrote to the Chair of the Parents Committee, the Chairs of the Governing Boards of Laurentia and Laurentian Elementary Schools and Laurentian Regional High School, and the Principal of Mountianview High School explaining the role of a commissioner and encouraging them to share with stakeholders that a commissioner seat was open in electoral division #2 (Lachute);

WHEREAS eligible candidates had the opportunity to present themselves at the December 6, 2017 meeting of the Sir Wilfrid Laurier School Board Corporate Committee and the December 7, 2017 meeting of the Sir Wilfrid Laurier School Board Parents Committee;

WHEREAS the Parents Committee was consulted on December 7, 2017 and feedback was received and shared with the Council of Commissioners;

WHEREAS the Council of Commissioners of the Sir Wilfrid Laurier School Board would like to thank all persons who submitted an application for the vacant commissioner seat in electoral division #2;

Commissioner Peter MacLaurin MOVED THAT **Melissa Wall** be appointed as Commissioner for electoral division #2 (Lachute), effective December 9, 2017.
